

TERMS & CONDITIONS – SSGC WALKATHON 2023

1. The Participant (or in the case of a minor, his or her parent/guardian on his or her behalf) understands and accepts that St. Stephen's Girls' College (the "Organizer") is the organizer of the Virtual Walkathon (the "Event"). Unless the context provides otherwise, the use of "we", "our" and "us" refer to the Organizer, and the use of "you" and "your" refer to the Participant in these Terms & Conditions.
2. The Participant must study these event rules and regulations carefully before enrollment. Upon submission of your application of entry, the Participant is deemed to have accepted and shall strictly adhere to all the Terms and Conditions of the Event, the Official Rules as stipulated and all announcements and guidelines that may be introduced by us from time to time.
3. The Participant agrees that he/she will observe all local rules and regulations, pertaining to the containment of the pandemic and will not flout any laws pertaining to wearing masks, maintaining social distances, non-contact and other such measures that may be put in place at all times. It is expected all instructions to be followed and safety measures adhered to from time to time in the best interest of your health and event safety.
4. By submitting an entry for the Event, the Participant consents to receiving information about this Event. A confirmed entry into the Event is non-refundable, non-transferable and cannot be modified upon submission. We will use email communication as its primary means of communication during the run up to the Event. The Participant agrees that any notice sent to the email address provided by the Participant to us in the entry shall deemed received.
5. We reserve the right to request the Participant to provide further proof of identity and entry submissions as we deem necessary. If the Participant fails or refuses to provide the requested information, we reserve the right to cancel the entry and/or participation of the Participant.
6. The Participant consents to the use of their name, result, image, photographs, video and comments in any school publications and for the compilation of statistical information in relation to this Event by us.
7. The Participant declares and warrants that he/she is physically fit and capable of safely participating in this Event. The Participant acknowledges that he/she will participate and complete the desired distance in a manner chosen by him/her, at locations chosen by him/her and at his/her own risk.
8. The Participant acknowledges that the Event is a virtual event and that we will not provide volunteers, marshals or medical personnel assistance to any participant. The Event is a self-supported activity and is meant to be an activity taken at the Participant's own risk and on his/her own resources.
9. The Participant understands and agrees that participation in the Event is voluntary and at the own risk of the Participant. We are not liable for any loss or disappointment suffered by the Participant for

taking part or not being able to take part in this Event. Each participant agrees to absolve us from any and all liabilities arising from bodily injuries, illness, accidents, death or other losses that might occur as a result of his/her participation in the Event.

10. Any person who is pregnant or suffering from any chronic disease such as heart disease or high blood pressure should not participate in the Event. All participants are urged to evaluate their physical condition and seek medical advice as necessary before participating in the Event. In case the Participant is feeling unwell, please stop participating in the Event immediately.
11. The Participant agrees to assume all risks associated with participating in this Event including, but not limited to, falls, contacts with other people, the effect of the weather, including high heat or humidity, traffic and the condition of the road and all other risks associated with a public event.
12. The Participant agrees to record his/her participation of the Event on an electronic device of his/her own choice to form his/her walking record. Each participant can complete the Event across multiple trials but his/her walking record and photo can be submitted ONCE only. The walking record and photo is deemed to be final upon submission. We understand the route and time recorded by different devices will be different and we will have absolute discretion with regards to the verification of results. All entries must be submitted no later than the registration deadline.
13. The Participant consents to our use of any photograph forming part of his/her entry in the Event, and to the extent applicable when the Participants confirms that he/she has obtained all necessary consent in connection with any photographic submission.
14. All information provided by a participant in the registration form must be true and accurate.
15. In the event of unforeseen circumstances, we may alter, amend or cancel the Event without prior notice. We reserve the right to change these terms at any time. Should there be disputes, we reserve the right to come to any final decision.

Use of Personal Data

16. We respect your legal rights of privacy. By using this website and enrolling in the Event, you consent to the collection and use of your information and personal data by us for all lawful purposes related to the fundraising activities of SSGC, SSGPS, SSGCKG and SSGCAA including administration and promotion of this Event. The purposes for which we may use the information and personal data collected include but are not limited to:-
 - a. replying to your enquiry or feedback;
 - b. processing your requests;
 - c. processing and confirming your participation in the Event;
 - d. processing and managing your donations;
 - e. issuing your receipt;

- f. announcing results
- g. communicating with you about Event-related announcements;
- h. verification of your identity; and
- i. event publicity (including publication of Event related content on our website and in our publications).

17. We shall have the absolute discretion to use and publish any photograph, video or any other record of the Event.

18. All personal data collected from you will be treated as confidential. We will not lease, exchange or sell any personally identifiable information that you have voluntarily supplied to us, including email address and telephone number.
